- Current curriculum vitae
- Three references to be completed in PHORCAS
 - Two of these references should be from clinical pharmacy practitioners who have worked directly with the applicant
- Transcripts

RESIDENCY SPECIFICS

Duration: 12 months- 52 weeks

Learning Experiences:

- Rotational experiences
 - 4 weeks in length, 3 required
 - 6 weeks in length, 4 required
- Longitudinal experiences: year long, 5 required
- Elective experiences: 4 weeks in length, 4 required

Number of Positions: 1 position

Application Deadline: January 3, 2025

Start Date: July 7, 2025

Stipend: \$52,000

Staffing

- Every fourth weekend
- One major and two minor holiday

Qualifications/Licensure

- Applicants must possess the Doctor of Pharmacy Degree from an ACPE-accredited program, or a program pursuing ACPE accreditation
- Applicants should be eligible for licensure in the state of Florida, and exams taken prior to the beginning of the residency program
- Applicants must complete an ASHP-accredited PGY1 pharmacy residency, or a PGY1 pharmacy residency program in candidate status
- Applicants are required to participate in the ASHP matching program

Benefits

- Medical, dental and vision insurance
- Paid time off: 22 days (includes holidays, vacation and sick days) Travel allowance for required professional meetings
- Space and equipment: laptop and desk space

REQUIRED LEARNING EXPERIENCES

Rotational Learning Experiences:

- 4 weeks in length, 3 required
 - Orientation (July)
 - Project (December)
 - Pediatric Emergency Medicine or Toxicology
- 6 weeks in length, 4 required
 - General Pediatrics (FLEX)
 - Neonatal Intensive Care Unit
 - Pediatric Intensive Care Unit
 - Pediatric Hematology/ Oncology

Longitudinal Experiences (1 year long, 5 required)

- Education
- Administration
- Research Project
- Ambulatory: Complex Care Clinic
- Service (Staffing)

Examples of other required projects:

- Two grand rounds presentations
- Journal clubs
- Drug class review/monograph/treatment guideline or protocol development
- Medication use evaluation/guidelines or quality improvement audit related to care for pediatric patients (*assigned in orientation*)
 - Poster presentation at ASHP midyear clinical meeting and exhibition
- Technician CE presentation
- PALS certification (if not obtained in PGY-1)
- Pharmacy committee involvement (1)
- ASHP teaching certificate (if not obtained in PGY-1)

Elective Learning Experiences

- Pediatric cardiac critical care
- Pediatric emergency medicine
- Toxicology
- Pediatric Nutrition
- Psychiatry
- Pharmacy Leadership
- Pediatric Infectious Disease

Additional Elective Rotations

- Residents can repeat a required or elective learning experience once during the residency year
- Other electives may be available at other sites in the city as well as new electives may be developed.
